The Carpet Export Promotion Council invites applications from registered member-exporters of this Council for their participation in the **Hong Kong International Home Textiles and Furnishing Fair at Hong Kong Convention and Exhibition Centre, Hong Kong from 20-23 April 2019** in anticipation of the Govt. approval and receipt of financial assistance from the Govt. The Hong Kong International Home Textiles and Furnishings Fair is the biggest event of its kind in Asia where exhibitors of Home Textiles, Furnishing including Carpets & Floor coverings, Door Mat, Floor Mat, and Furnishing Fabric etc. will showcase various quality of their products. This Fair is organized by Hong Kong Trade Development Council coinciding with the Hong Kong Houseware Fair.

During 2018 there were 305 exhibitors from 9 countries and regions, including exhibitors from Bangladesh, the Chinese mainland, Hong Kong, India, Indonesia, Korea, Lithuania Taiwan, Portugal, Thailand, Belgium & Vietnam showcased various range of Home Textiles, Carpets and Furnishing items.
