The Carpet Export Promotion Council invites application from registered member-exporters for participation in the 2019 China (Qinghai) International Carpet Exhibition at Xining (China) from 2nd to 6th August 2019. We are proceeding in anticipation of the Govt. approval and receipt of financial assistance from the Ministry of Textiles, O/o. the Development Commissioner (Handicrafts).

This is the largest retail Carpet & Floor coverings fair in Xining, China organized by the China Tibetan Carpet Association (CTCA). This Show provides an opportunity to the Indian Carpets Exporters to showcase their wide range of products before the potential buyers. The Organizers have informed that exhibitors from seven major handmade carpet producing countries, such as India, Iran, Pakistan, Nepal & Afghanistan, Turkey & Turkmenistan will show case their products and buyers from more than 30 countries and regions including European countries, United States, Japan, Russia, Canada, Indonesia, Brazil etc. will be visiting this fair. 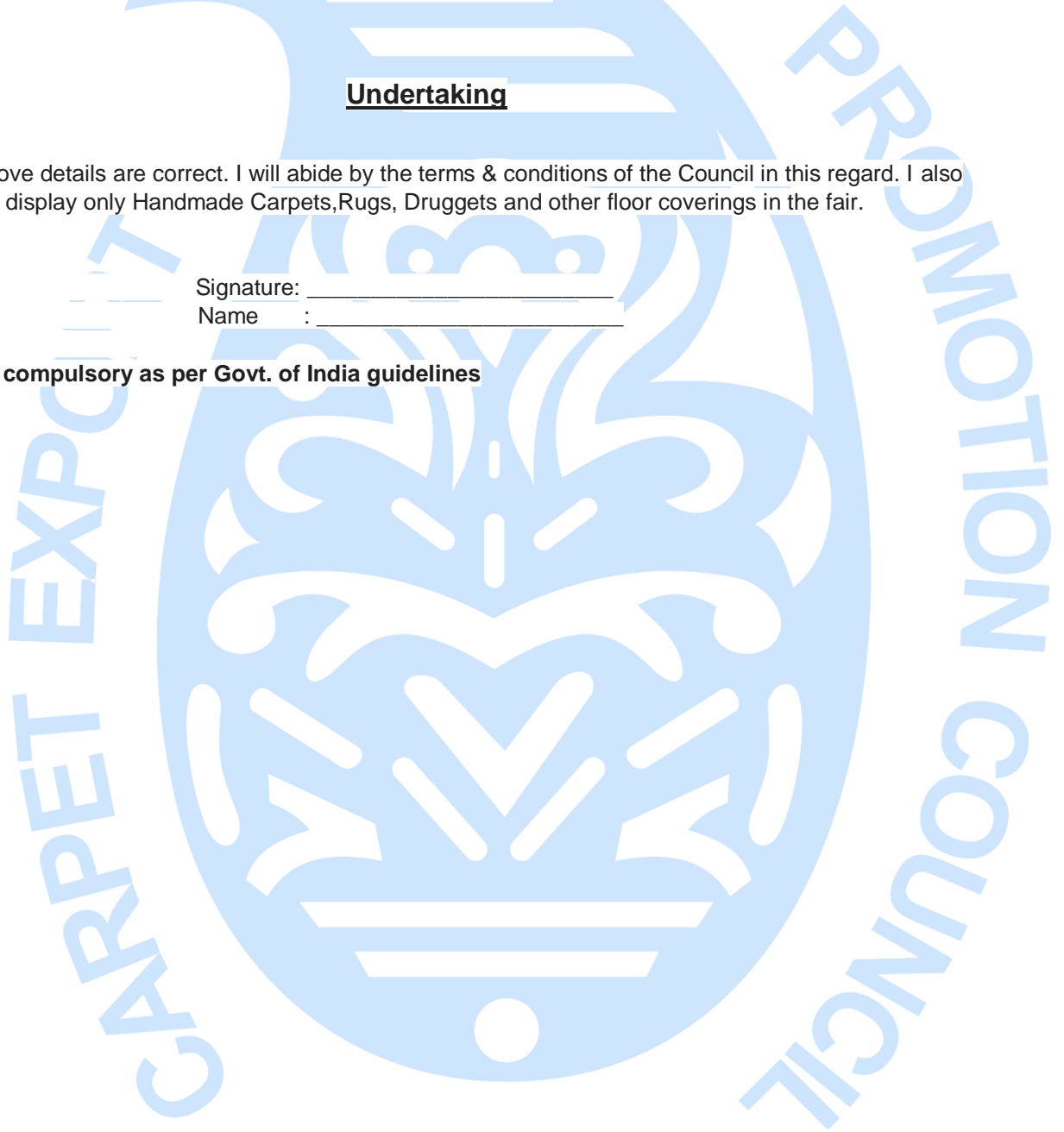
