ELECTION FOR THE OFFICE OF CHAIRPERSON & VICE CHAIRPERSON OF THE CARPET EXPORT PROMOTION COUNCIL FOR 2025.

Dear Members,

Further to circular No. CEPC/ELE-2025/Cir.No.1 Dated: 24th October, 2025, this is to inform that the Office of DC (Handicrafts) vide letter No. DCH/CPT/5(1)/2020-21/CEPC-Part(1)/43 dated 12 November 2025 has clarified as under :

"It may be highlighted that as per the Article 4 (c) of the New Article of Association (AoA) of CEPC, a COA member is eligible to contest election for the post of Chairperson or Vice Chairperson: given that the person or the entity represented by the person has minimum average exports of Rs 2.5 crores of the product to its credit during the two financial years immediately preceding the election. The amount of exports in the above eligibility criterion is reduced to 1.25 crores in case of a product manufacturer. A certificate issued by Chartered accountant shall be required for establishing the above eligibility

Hence, a CoA member may choose to contest election for the post of chairperson or vice chairperson by representing himself from any legal entity which fulfills the eligibility criterion mentioned in para 2 above.

This clarification is issued in terms Article 45 of the AoA to promote smooth transition from the position prevailing before the adoption of the new AoA vis a vis to the position resulting after the adoption of the new AoA."

In view of the above clarifications, COA Members *may choose to contest election for the post of chairperson or vice chairperson by representing himself from any legal entity which fulfills the eligibility criterion mentioned in para 4.2.c of the Articles of Association of the Carpet Export Promotion Council.*
