Participation charges will be subsidized, if the council receives approval from the Office of the Development Commissioner (Handicrafts). The quantum of financial assistance will be informed after the receipt of approval from the office of DC(H). If approval from financial assistance is not received, participation will be on a cost-recovery basis.

1. The participation guidelines of the organizer i.e., HGH, shall be applicable. The Council/show organizer reserves the right to select participants.
2. The submission of an Expression of Interest and Deposit of Fee should not be treated as confirmation of Participation. The incomplete Expression of Interest will not be considered.
3. The participation is subject to the receipt of a sufficient number of applications or space finally made available by the organizer.
4. Those not submitting expressions of interest may also be considered, subject to the availability of space only.
5. The members also need to apply for space and deposit their participation charges as and when demanded through the circulars of the respective fair that will be issued by the Council through mail, and charges paid now shall be adjusted accordingly.
6. CEPC reserves the right for selection of participants based on the receipt of applications of respective fairs, space availability, and other terms as decided by the competent authority.
7. The expression of interest is refundable only if Space is not allotted / participation in the fair is canceled or withdrawn by members before allotment of space in the respective fair.
8. Council's participation is subject to receiving an adequate number of applications.
9. The Council will reimburse a portion of the participation charges to member exporters after the event, subject to the receipt of the financial grant from the Office of DC(H), and only if the approval is granted.
10. The expression of interest and participation charges are non-refundable if:
 - a. Withdrawal by the applicants after allotment of the Booth by the Council.
