Dear Members,

We are pleased to inform you that the Carpet Export Promotion Council (CEPC) is organizing participation in DOMOTEX asia/CHINAFLOOR, scheduled from 27-29 May 2026 at the National Exhibition and Convention Centre (NECC), Shanghai, China.

DOMOTEX asia/CHINAFLOOR is a premier international trade fair for carpets, flooring, and related products. In its 28th edition, the exhibition provides a dedicated pavilion for Indian carpet producers and offers a valuable platform for global manufacturers, designers, and buyers to connect, explore market trends, and expand business opportunities in China and the Asia-Pacific region.

Exports under Chapter 57 to China stood at USD 18.46 million during FY 2024-25, indicating steady demand for handmade carpets. The Chinese market presents good potential, particularly for premium and value-added handmade carpet products, supported by growing consumer interest in quality home décor and interiors.

In this regard, CEPC invites Expressions of Interest (EOI) from interested member exporters for participation in the event. To facilitate planning and to secure space with the fair organizers, members are requested to submit an EOI along with an advance payment of ₹25,000/- on or before 28.02.2026.

The cost of a 12 sq. mtr. built-up booth, without any financial assistance, is Rs 3,50,000.00

The Council has submitted a proposal under the Market Support Scheme (MSS) of the Office of the Development Commissioner (Handicrafts), Ministry of Textiles, seeking financial assistance. **Subject to approval, the participation charges are expected to be in the range of ₹1.00 lakh to ₹1.75 lakh.**

The subsidy amount, if approved, shall be reimbursed post-event, subject to the final quantum of financial assistance sanctioned by the Office of the Development Commissioner (Handicrafts). **In case the proposal is not approved, participation will be on a cost-recovery basis.**
